


鉴 定 结 论

3	如果电池或电芯带有结实并可抵御碰撞的保护性外套,毛重达 12kg 以上,这样的电池或电芯可装在结实的外包装中,也可以不经包装装入保护箱(如全封闭木箱或板条箱),还可以装在托盘上。但电池或电芯须被妥善防护,以防电池移位,并且接线柱上不得叠放其他电池。 For cells or batteries with a gross mass of 12kg or more employing a strong, impact resistant outer casing, and assemblies of such cells or batteries:     (a) Strong outer packagings, in protective enclosures; or     (b) Pallets or other handing devices.     Cells or batteries shall be secured to prevent inadvertent movement, and the terminals shall not support the weight of other superimposed elements.
4	当电池或电芯与设备包装在一起时,它们须被包装在满足包装类 II 要求的纤维板内包装中。 其设备必须防止在内包装中产生移位。 For cells or batteries packed with equipment: Packagings conforming to the requirements of 4.1.1, 4.1.3 and Packing Group II performance standards, then placed with the equipment in an outer packaging. The equipment shall be secured against movement within the outer packaging.
5	电池或电芯内含在设备中时: 其外包装件必须是根据包装容量及其潜在用途而设计制造,并用合适材料制作成的坚固外包装,该设备须装在高强度的外包装里,并防止运输期间的意外启动。 For cells or batteries contained in equipment: Strong outer packagings constructed of suitable material, and of adequate strength and design in relation to the packaging capacity and its intended use. They shall be constructed in such a manner as to prevent accidental operation during transport.
6	每个电池或电芯应加有安全通风装置或被设计成在正常运输条件下不会突然爆裂; Each cell and battery shall incorporate a safety venting device or is designed to preclude a violent rupture under conditions normally incident to transport.
7	每个电池或电芯应装有防止外部短路的有效装置;和包含有并联着的多个电芯或电芯系列的每一个电池组都应该装有防止反向电流的有效设备(例如:二级管、保险丝等)。 Each cell and battery shall be equipped with an effective means of preventing external short circuits; and Each battery containing cells or series of cells connected in parallel shall be equipped with effective means as necessary to prevent dangerous reverse current flow (e.g., diodes, fuses, etc.);
